## With a Down Payment Assistance grant, you don't need to wait to buy a home

Saving for a down payment on your first home can take years. Now, PFCU is helping members buy a home by offering down payment assistance grants sponsored by the Cook County Bureau of Economic Development Department of Planning and Development. Qualifying members would need to contribute up to \$1,000, or 1% of the purchase price on a home; the grant will then cover the rest of the down payment up to \$24,000, or 6% of the purchase price.

## FTC reports rise in imposter caller scams

Your phone rings from an unrecognized number. "You are being listed as the primary suspect in a case being filed by the IRS," the voice might say. Or, "This is Microsoft. Your computer has been infected with a virus."

Is it really the IRS or Microsoft on the other end of the line? In a moment of panic over owing back taxes or having an infected computer, you might not stop to think that the call is coming from an imposter.

These types of impersonation robocalls are on the rise. According to the Federal Trade Commission (FTC), imposter scams were among the top complaints made to the agency last year.

The FTC recommends following steps to ensure you aren't duped:

**Stop and check it out:** DO NOT act on any requests from an unidentified caller, whether for money or your personal information. Research before acting and contact trusted authorities for help. Remember, you are in control.

**Tell your friends:** If you receive a suspicious call, your friends and family may have as well. The more people who talk to one another, the more information comes to light about the truth of imposter calls.

**Report scams:** If you suspect you were contacted by an imposter, report it to the FTC by calling 877.FTC.HELP (877.382.4357) or TTY 866.653.4261. Filing a complaint will help make the FTC aware so they can investigate.

**Stay aware:** Sign up for free scam alerts from the FTC at www.ftc.gov (on the toolbar, go to tips and advice  $\rightarrow$  for consumers  $\rightarrow$  scams  $\rightarrow$  get email updates).
